## Prep Work

### College Preparation



#### Claim and Focus

This essay begins with a specific claim ("I think that for me I did a good thing..."), but does not maintain focus on this claim throughout the entire essay. Opinions outweigh a formal argument, and off-topic tangents emerge ("I hope that I can find a good roommate who is nice and doesn't steal my stuff"). A possible counterclaim is introduced ("If I had started thinking about college before now..."), but it is without development.



#### Support and Evidence

Some evidence is offered to support the claim ("School and work make me so busy" and "I didn't want to get to senior year and have to worry about what I was going to do after school"), but it is not particularly strong or developed. Most of the essay provides general information about the student's personal experience, rather than specific (or cited) evidence to support a clear claim. No evidence is provided to support the attempted counterclaim.



#### Organization

This essay has a basic organizational structure (intro, body, conclusion), but it is simplistic and repetitive in nature. The conclusion is identical to the introductory paragraph, rather than even being a rephrasing of the information. Also, the relationships among the ideas within the essay, particularly within the body of the essay, are not consistently clear and often stray off topic because of a basic word association (mention of roommate leads to discussion of brother's roommate stealing food).



#### Language and Style

The sentence structure used in this essay does not vary, creating a monotonous tone. There is distinct repetition of words from the introduction to conclusion, and an informal style is used throughout essay ("gonna," "much much more"). Furthermore, errors in conventions that could potentially interfere with meaning occur throughout the essay.



#### Using Exemplars in Your Lessons

Exemplar essays are tools to take abstract descriptions and make them more concrete for students.
